

Wahnapiatae First Nation Member Funeral Grant Policy

The Wahnapiatae First Nation Chief and Council approve this policy to assist the membership with funeral costs.

PROCEDURE:

- This is a grant and is not to be considered as income.
- Individuals will complete the attached application form (Appendix A) and submit it by mail or by email to the membership clerk.
- Individuals have **six months** from the date of death to apply for the grant.
- This grant is intended only for addressing funeral costs for a registered band member, for spouses of registered band members living on reserve, and for employees of the band living on reserve only if no other assistance is available.
- Payment will be made directly to the funeral service and/or traditional service agency which is providing services for the funeral upon receipt of an original invoice and proof of death document, or to the applicant with proof of payment. Invoice and proof of death document will still be required with proof of payment.
- This grant shall not exceed 50% of funeral costs less any grants or funding up to a maximum of \$5,192.44.
- Any costs above the grant amount will be the responsibility of the person who is overseeing the arrangements for the deceased.
- Attached is an agreement (Appendix B) Wahnapiatae First Nation has entered with Lougheeds Funeral Home. They offer a Band Package for all who qualify for this grant. If the Band Package is utilized, the full cost of the package will be covered under this policy less any additional grants or funding.

AMENDMENTS:

Chief and Council can amend this policy from time to time.
